

Terms and Conditions

For the sole use between Music Box and the Client.

Within this document the term Client is the person making the booking and is therefore responsible for the booking thought out. The term Company or dj refers to anybody associated with MUSIC BOX.

1- Booking details.

- A All bookings are taken on a booking form and it is the responsibility of the client to make sure all that all details are correct at time of booking.
- B The client ensures that all details of the venue are correct and if the dj inspects the venue to find any differences the company will report to the client to confirm this matter.
- C There will be adequate set up time available usually 90 minuets before the start time of the gig and 60 minuets after the gig to break the set down. The client should indicate what access is available, stairs, lifts, Car parking etc.
- D The client and company both confirm that there is no third party interests on the booking and no previous bookings of these dates for this event.

2- Payments of events other than weddings

A The client will pay by cheque a deposit as confirmation of the event made payable to P.H. Atkins
The client will then pay the outstanding balance to the DJ on t arrival, in cash only.

3- Payment of wedding functions

A
The client will pay a deposit to the company for confirmation of the booking, then full payment should the company by 14 days before the wedding.

4- Cancellations.

- A Should the client which to cancel within 4 weeks of the event then half the deposit will be returned, unless the date is for filled by the company, should the date be cancelled after this time then the full deposit shall not be returned.
Should the date be cancelled for no reason of the client ie a Function room failure, death etc. then the deposit will be returned in full or a new date set if required.
- B The company will try to fulfill its obligations in the events of unforeseen circumstances by any other means should this be necessary.

5- Conduct

- A It is the clients responsibilities to ensure that all guests conduct themselves in a proper manner at all times. The client must be responsible able for all guests and their actions. In the event of a minors function there must be the legal ratio of responsible persons to minors.
- B The company will act in a fully responsible attitude at all times, during there attendance to the venue, it will set up and run as requested by the client unless the legal requirement is different which will be pointed out and stated.
The company will be responsible for producing certificates of Public Insurance. And P.A.T. Testing carried out on our equipment.

6- Security.

- A The client will be responsible for the safety and security of any theft of items of the company, including their vehicles while on site.
- B The company is not liable for any damage on the venue, any potential hazard must be pointed out by the client or the venue staff at the time of set up.

7- Health and Safety

- A The company will adhere to all rules and regulations of the health & safety at work act. The client must adhere to the above and adhere to this act. Subject to failure to conform to the above act the company can not take any further part of the event and the full amount of the event has to be paid.
- B The client must ensure that the venue has all the agreed quiescences and works within the above act.
- C The company will carry it's certificates as already stated.

8- The Venue

- A The client must ensure that all the venue has all legal, and conforms with all the local bye laws as the company can not perform in a venue that has not got all of the above mentioned.
- B. The client must ensure that there is adequate parking for the dj on the night for off loading and loading of the equipment, in a safe and secure manner. Should there be items stolen during this procedure it is the responsibility of the client.
- C. The venue must supply a minimum of 2 13 amp sockets that comply with local regulations, for the sole use of the dj for that night. Failure to supply these or the dj finding a fault with these items they can not be used, the venue must supply the above items for sole use, and failure to that the dj can not work and the fee must be paid in full.

Refreshments

As the dj works very unsociable hours we ask if non alcoholic drinks could be supplied.

Please do not offer alcoholic drinks whilst our staff are on the venues premises.
